School Facility Conditions and Planned Improvements (Most Recent Year)

Oak Crest Middle School was built in 1957. However, the campus now includes original buildings as well as structures that have been modernized and buildings constructed since the school's conception..

The custodial crew and ground-keepers help to ensure the campus is clean and in good working order. Requisitions are made on a regular basis to fix and maintain working order on campus. All classrooms and restrooms are cleaned on a daily basis.

Technology is continually updated. Each classroom is equipped with ceiling mounted LCD projectors and most classrooms have document cameras. Staff and student computers were updated as needed including a newly updated computers in one of the computer labs. Additionally, 83 new mobile devices, Chromebooks, were purchased for student use. Audio/video cabling was installed throughout the school to provide live and taped video broadcasts to all classrooms. Software was purchased or updated to provide teachers with quality programs to support instruction.

More facts about the condition of our school buildings are available in an online supplement to this report called for by the Williams legislation of 2004. What you will find is an assessment of more than a dozen aspects of our buildings: their structural integrity, electrical systems, heating and ventilation systems, and more. The important purpose of this assessment is to determine if our buildings and grounds are safe and in good repair. If anything needs to be repaired, this assessment identifies it and targets a date by which we commit to make those repairs. The guidelines for this assessment were written by the Office of Public School Construction (OPSC) and were brought about by the Williams legislation. You can look at the six-page Facilities Inspection Tool used for the assessment on the Web site of the OPSC.

School Safety Plan

Staff members monitor school grounds throughout the day to ensure safety. The staff reviews rules and procedures with staff and students to ensure the expectations are clearly communicated to facilitate safe and responsible behavior. A staff school culture/safety committee reviews the safety plan annually and meets regularly throughout the school year to discuss safety issues and prevention. Fire, lockdown, and earthquake drills are conducted throughout the school year. All classrooms are equipped with a telephone and are connected to our two-way intercom system. School administrators, custodians, secretaries, and the school nurse all have walkie-talkies to help with efficient and immediate communication. Oak Crest is a closed campus – all visitors are required to check in at the office when on campus.

The federal law known as No Child Left Behind requires that all schools and districts meet all three of the following criteria in order to attain Adequate Yearly Progress (AYP): (a) a 95-percent participation rate on the state’s tests, (b) a CDE-mandated percentage of students scoring Proficient or higher on the state’s English/language arts and mathematics tests, (c) an API of at least 740 or growth of at least one point.
