- A. Applications for payment authorization must be submitted to the District Business Office for approval in advance.
- B. Eligibility will be established by the Associate Superintendent of Business Services following guidelines within the policy.
- C. The parent will be responsible for submitting claims on appropriate district forms at the end of each semester.

II. EXCEPTIONAL STUDENTS

- 1. The transportation needs of exceptional students shall be surveyed by the Eligibility and Planning Committee when the student is recommended for placement in a special school or program.
- 2. Reimbursement for the costs of providing transportation for exceptional students will be provided monthly as reported by the parent or guardian on the appropriate district forms.
