SUBJECT: Approval of Classified Salary Increase

EXECUTIVE SUMMARY

On December 14, 2006, the District concluded negotiations and reached an agreement with the California School Employees Association (CSEA), Chapter 241. This agreement was approved by the Board of Trustees on January 18, 2007. Article 11B-Wages states:

"There shall be an increase to the salary schedule for 2006-2007 of 5.92% effective July 1, 2006. (See Appendix B and Appendix C). Effective July 1, 2008, the salary will be increased by 2.84%. The certificated unit received a salary schedule increase of 8.76% on 7/1/06. For the duration of this agreement, should the salary schedule of any other employee group (i.e. certificated, confidential, supervisory and management) be increased by more than the 8.76% listed above, the classified unit will receive the same percentage increase on the same implementation date. Further, should any employee group (as defined above) receive any increases to the Flex Plan beyond the current benefit structure, the classified unit will receive the same increase."

Therefore, an additional 2% will be added to the classified salary schedule effective 7/01/07.

RECOMMENDATION:

It is recommended that the Board of Trustees approve the 2007-08 Classified Salary Schedule.
