SUBJECT: ADOPTION OF RESOLUTION FOR EMERGENCY

WAIVER – PUBLIC PROJECT

EXECUTIVE SUMMARY

The San Dieguito Union High School District Board of Trustees and the San Diego County Office of Education (SDCOE) has been previously contacted regarding the need to grant an Emergency Waiver to enter into a contract for repair work of a fire main break at La Costa Canyon High School. The estimated cost of this contract is in excess of the \$15,000.00 bid limit for public works contracts. This Emergency Waiver, which must be unanimously approved, is required to allow the District to conduct the emergency repairs of an immediately hazardous situation without advertising for or inviting bids.

On August 7, 2009, a 6-inch fire sprinkler water main ruptured underground at our La Costa Canyon High School. Water to the campus was shut-off immediately and damage assessment was made. The scope of work necessary to complete repairs includes coring, alarm work and labor to dig the underground fire main up and relocate the existing riser to the outside of the building and abandon the existing underground piping under the building. The drain piping and the alarm devices will be relocated to the outside of the building and the hole will be back-filled 4-inches below the existing concrete to allow new concrete to be installed. Cost for this work excluding new concrete is \$17,700.00. The cost of the new concrete is unknown at this time, but it is expected to be less than \$15,000.00.

Staff and students are scheduled to be on campus soon and the Carlsbad Fire Department has mandated visual observation/fire watch.

Upon adoption, this resolution will be sent to the County Superintendent of Schools for formal consideration.

RECOMMENDATION:

It is recommended that the Board adopt the attached resolution determining that circumstances constituting an emergency condition exist and request approval from the County Superintendent of Schools to enter into contracts for proper repair or replacement of a fire sprinkler water main at La Costa Canyon High School without advertising or inviting bids pursuant to Public Contract Code section 20113 (school districts) / 20654 (community college districts) and Public Contract Code section 1102.

WHEREAS, on August 7, 2009, a 6-inch fire sprinkler water main ruptured underground at La Costa Canyon High School. Water to the campus was shut-off immediately and damage assessment was made; and

WHEREAS, the scope of work necessary to complete repairs by Cosco Fire Protection includes coring, alarm work and labor to dig the underground fire main up and relocate the existing riser to the outside of the building and abandon the existing underground piping under the building. The drain piping and the alarm devices will be relocated to the outside of the building and the hole will be back-filled 4-inches below the existing concrete to allow new concrete to be installed by others; and

WHEREAS, the cost for this work excluding new concrete is \$17,700.00. The cost of the new concrete is unknown at this time, but it is expected to be less than \$15,000.00; and

WHEREAS, time is of the essence to comply with the Carlsbad Fire Department's mandated visual observation/fire watch and to properly complete the repair before staff and students return to school; and

WHEREAS, Public Contract Code section 20113 (school districts) / 20654 (community college districts), as further defined by Public Contract Code section 1102, provides that school districts/community college districts may, with the unanimous approval of the governing board and approval of the county superintendent of schools, contract for the performance of labor and purchase of materials without advertising for or inviting bids in an emergency when such work is necessary to permit the continuance of existing school classes or to avoid danger to life or property;

NOW THEREFORE, be it resolved that the Governing Board of the San Dieguito Union High School District has determined that these circumstances constitute an emergency condition and request approval from the county superintendent of schools to enter into contracts for proper repair and replacement of a fire sprinkler water main at La Costa Canyon High School without advertising or inviting bids pursuant to Public Contract Code section 20113 (school districts) / 20654 (community college districts) and Public Contract Code section 1102.

On August 7, 2009, a 6-inch fire sprinkler water main ruptured underground at our La Costa Canyon High School. Water to the campus was shut-off immediately and damage assessment was made. The scope of work necessary to complete repairs includes coring, alarm work and labor to dig the underground fire main up and relocate the existing riser to the outside of the building and abandon the existing underground piping under the building. The drain piping and the alarm devices will be relocated to the outside of the building and the hole will be back-filled 4-inches below the existing concrete to allow new concrete to be installed. Cost for work excluding new concrete is \$17,700.

Your concurrence is needed for the district to proceed. A payment bond will be furnished before allowing the performance of any public work costing more than \$25,000.00.

A formal resolution will be acted upon by our governing board on August 20, 2009 and a copy will be sent to you so that formal approval from the County Superintendent of Schools may be considered and granted.
