- 4. I will not litter or throw objects inside the bus or out of the bus windows.
- 5. I will not vandalize the bus.
- 6. I understand that smoking and/or the use or possession of any illegal substances is strictly forbidden.
- 7. I will not eat on the bus.
- 8. I understand that fighting of any kind will not be tolerated.
- 9. I understand that creating or participating in any type of disturbance on the bus will not be tolerated.
- 10. I will follow the directions given by the bus driver.

Transportation School Bus Stop Procedures 2021 / 2022

The following procedures apply only to the following school bus routes:

- Torrey Pines H.S. Shuttle
- Sunset H.S. Shuttle

Health Screening Prior to Boarding the School Bus

As described in the Parent/Guardian Health and Safety Agreement for In-Person Instruction for the 2021-2022 School Year, the parent/guardian understands and agrees that all students shall undergo a District administered health screening prior to entering the school bus or district vehicle.

Parents/Guardians are encouraged to be at the school bus stop with their students, however, it is not a requirement.

In the event that your student does not successfully complete the screening process, they will not be allowed to board the bus and go to school. The bus driver will direct the student remain near the entrance door until contact is made with the dispatch office. Dispatch will contact both the parent and the school. Procedures are listed on the reverse side.

In order to provide transportation for your student(s), the following must be completed.

Transportation Department Procedures

A student that answers "Yes" to any of the screening questions will remain outside of the bus until the bus driver successfully makes contact with the transportation dispatch office via 2-way radio.

The dispatch office will contact the parent/guardian of the student to inform them that their student did not successfully complete the screening process and will be directed to return home.

The dispatch office will also notify the school of attendance.

General Procedures

- Leave home early enough to reach the school bus stop at least 5 minutes before the school bus is scheduled to arrive. Do not play or run around at the bus stop or make loud noises.
- Walk. Do not run to the bus stop. Stay on the sidewalk. If there is no sidewalk, stay as far as possible away from traffic. Walk facing on-coming traffic. Cross the street only at intersections/crosswalks with an official traffic control signals.
- Never cross the street behind the bus
- Follow the directions of the bus driver at all times.
