


# HELP US KEEP OUR SCHOOLS

**News!** SDUHSD has partnered with Phamatech Laboratories & Diagnostics to bring free onsite PCR testing for students & staff identified as close contacts or who have symptoms. More information to follow soon! (And remember, **please** stay home if you have symptoms!)

Wear your mask when you are indoors. Face coverings means a surgical mask, a medical procedure mask, a respirator worn voluntarily, or a highly woven fabric or non-woven material of at least 2 layers. A face covering should not have visible holes or openings, and must cover both the nose and mouth. Face coverings are required indoors; recommended outdoors for individuals who are not vaccinated to reduce exposure. The following are not considered face coverings: scarf, ski mask, balaclava, bandana, turtleneck collar, or single layer of fabric.

Symptoms? Please stay home!!! **Did you know that something as simple as a runny nose is a symptom?** The most common symptoms include: cough, fatigue, fever or chills, muscle or body aches, headache(s), new loss of taste or smell, sore throat, congestion or running nose, nausea or vomiting, diarrhea. Most district cases have involved individuals who knew they had symptoms and still came to work or class. **PLEASE STAY HOME IF SYMPTOMATIC.** Staff must report illnesses to HR and be tested. Students must call to report all absences to their school.





### **SDUHSD Safety Measures & FAQs**

SDUHSD COVID-19 Safety Plan and Practices website

### The safety of our students and employees is always a top priority and the below information is shared so that our families and employees know they are in good hands.

To operate schools, indoor masking is required during all school activities by the **California Department of Public Health (CDPH).** SDUHSD promptly implemented this, and this requirement is being strictly enforced. The CDPH also provides ideas on optional safety layers for districts to consider to reduce the spread of COVID-19. Each district adopts the layers as they choose as these additional layers are not required by the CDPH.

SDUHSD is fortunate to have the resources to be able to implement safety measures that exceed CDPH requirements. Examples of additional layers of safety in SDUHSD include HEPA devices in all classrooms and workspaces, handwashing stations and more! SDUHSD has also provided 3 vaccination clinics over the summer so that our students and community members had access to free vaccinations locally. We recently brought onsite testing to our sites as well. Not all districts have HEPA filters, handwashing stations, vaccination clinics, or onsite testing. Each layer in place throughout SDUHSD supplements one another, strengthening the CDPH's masking requirement.

Below are more details of the safety layers and practices available at SDUHSD:

1. **Masks:** SDUHSD requires and enforces the wearing of masks indoors at all its sites in compliance with CDPH guidance. (Masks are optional outdoors). Students should bring their own masks that fit their face without gaps. Masks are available onsite if needed. SDUHSD provides bell covers for musical instruments as an added safety layer to band students.



SDUHSD currently has an administrative regulation in effect for student masks, AR 5132.1 (Student Mask and Face Covering). A proposed amended version of this AR was listed on the Board's 8/19/21 Agenda to provide an opportunity for members of the public to give input. This input will be considered when updating the AR.

SDUHSD also provides N-95 respirators in the appropriate size to all employees who are not fully vaccinated "upon request" for **voluntary** use. (Fit testing is not required when a respirator is provided for voluntary use.)



**Mechanical Ventilation:** Our highly experienced Maintenance and Operations department carefully monitors our HVAC systems and promptly handles any maintenance or repairs as necessary. As of 8/30/21, our school sites either have no mechanical work orders open, or very few, which should provide added reassurance at how well our sites are being managed. In the rare event a repair cannot be immediately addressed, alternative work spaces are provided until a repair can be made. Work orders related to ventilation are prioritized.

5. HVAC Systems: Per CDPH Safety Measures for K-12 Schools, the District has used the ventilation recommendations to optimize the HVAC systems to the greatest extent possible. The HVAC systems tied to the District's energy management system (EMS) have been programmed to provide the California Title 24 code-required outdoor air ventilation. HVAC systems not tied to the District's EMS or spaces without any HVAC system have been supplemented with portable air cleaners. In consultation with CDPH, HVAC system filters have been upgraded to MERV 12 filters. Spaces that continue to have MERV 8+ or MERV 12 have further been supplemented with portable air cleaners. Over the summer, the District was able to have select HVAC systems at the end of their useful life at Canyon Crest Academy, Oak Crest Middle School and La Costa Canyon High School replaced with new HVAC systems that have been installed with MERV 13 filters. The District has also accelerated the replacement schedule to up to four times a year (or every three months) as practicable, which exceeds the normal school replacement recommendation of two to three times a year. Not all districts do this.

4. Portable Air Cleaners: Even though HEPA filters are not required in classrooms by CDPH, the District has purchased portable air cleaners using HEPA filters to bring an added layer of protection. The District has placed portable air cleaners in all instructional spaces as practicable. Per the CDPH, HEPA units provide "substantial protection" even in classrooms with "non-functioning or poorly functioning [HVAC] systems."



HEPA filters may have a "pre-filter" that can appear dirty. This dirt should not cause alarm and demonstrates that the pre-filter is working properly. If the pre-filter or the HEPA filter are no longer working correctly, a red indicator turns on signaling that a filter replacement is needed. Once a red indicator light turns on, employees submit filter change requests to their site administrators, who then submit work orders to the District's Maintenance and Operations division. Filters are available through Maintenance and Operations and delivered to the site plant supervisor to service the unit.



**Natural Ventilation**: SDUHSD encourages the use of natural ventilation where it is safe to allow instruction to occur outside or to open windows and doors when conducting instruction inside as an additional safety layer.

6. Notifications: When an individual has been within 6' of an individual who has tested positive for COVID-19 for 15 minutes over a 24 hour period, SDUHSD follows the State of California's close contact notification requirements. The purpose of close contact notifications is to notify individuals who may be at risk by virtue of being a close contact so that they can take steps as appropriate based upon their vaccination status and other considerations per the <u>Decision Tree</u> of the San Diego County Office of Education (SDCOE).



Per the CDPH (and CDC), efforts to locate and communicate with close contacts must be done in a manner that preserves the confidentiality and privacy of all involved. Members of the public have on occasion requested that SDUHSD share additional information that exceeds state and county requirements, however the CDPH and SDCOE do not require the disclosure of the actual classes in which a student or employee were located, which can lead to a breach of confidentiality of an individual who has tested positive in violation of California's privacy laws.

Individuals who are not defined as close contacts are not required to quarantine or test. **Individuals** who are vaccinated are not required to quarantine or test if they do not have symptoms. Quarantine and testing are only required in the instance of close contacts. If a child receives a notification that they are a close contact, as noted above, the District offers free testing, which the family is alerted of through the close contact notification. Families may select this free district provided option, or exercise other options including getting testing at their own health care provider or pharmacy.

7. **Staffing:** San Diego County school districts are experiencing staffing shortages throughout the County.



SDUHSD has hired subs and redirected staff as appropriate, and when available, to support our sites with contact tracing and other needs though we continue to have numerous positions open.

Please consider helping the District with its staffing shortages by applying through <u>EdJoin.org</u>.

**IMPORTANT:** In the event a family believes that a student's health would be put at risk by in-person instruction despite the added safety measures SDUHSD has in place, SDUHSD also offers an <u>Independent Study</u> for the 2021-22 year per California's Assembly Bill 130.

8. **Symptomatic Individuals:** The SDUHSD Safety Plan & Practices <u>webpage</u> and the SDCOE Decision tree both state that individuals who are symptomatic must stay home and be tested. This is very important and we are again requesting that if your child has symptoms, do not send them to school and contact your school site to obtain information about next steps. Symptoms are listed on the <u>SDUHSD Safety Plan & Practices webpage</u> as well.

If a student is symptomatic while on campus, school staff should immediately refer the student to the school's main office for the student to be picked up, taken home and tested. Please let the site administrators or the District know if this process is not followed so that the District can investigate this situation. Please note that per the SDCOE decision tree, if students were masked in class - as they are required to be while indoors, individuals who are vaccinated may stay in school.

Students who are home due to illness or quarantine have access to their teacher's Google Classroom during their absence to reduce the impact of their absence from in-person instruction. In the event a parent or guardian believes that their student's health would be put at risk by in-person instruction, the District offers an <u>Independent Study</u> option.

Free testing of symptomatic students and staff will be available at some of our school sites. An initial roll out of testing has started and will be available at two sites each week in the northern part of the district, and two sites in the southern part of the district to increase access and help staff and students return to school more quickly.

School employees who are symptomatic are eligible for free testing now and should contact HR for additional information.

9. **Testing Generally**: SDUHSD currently offers testing by appointment for staff and close contact students through a contract with UCSD. (Individuals who are eligible for this testing option will receive information from the District).

**Screening testing of school employees?** On 8/11/21, the State of California issued a public health order requiring surveillance or screening testing of school employees who had not documented their vaccination status, with an implementation deadline of 10/15/21. The State did not require surveillance testing of students.

As of the week of August 30, 2021, far ahead of the 10/15/21 deadline, SDUHSD started weekly PCR screen testing for staff who have not provided proof of vaccination, and for students who are identified as close contacts to limit their time out of the classroom.

Testing will be offered to students and staff twice a week at two school sites in the northern part of the district, and twice a week at two school sites in the southern part of the district. The initial roll out of this testing option will be offered to students and staff in need of testing in order to return to school. Further notifications will follow once this initial phase is completed.

### 10. **Other:**

### a. Handwashing Stations

The District has added handwashing stations across all campuses to encourage staff and students to maintain good hygiene practices.

### b. Cleaning

The District is also cleaning classrooms and offices daily, documenting the areas that have been cleaned on a checklist posted in the classroom/office, so it is transparent for the teacher, staff and students.



# A GUIDE TO MASK USE



Before putting on a mask, clean hands with alcohol-based hand rub or soap and water. Per CDPH guidance issued 8/6/21, "face coverings are recommended for unvaccinated persons outdoors where six feet of distancing cannot be maintained."



- 1. Cover mouth and nose with mask.
- 2. Make sure there are **no gaps** between your face and the mask.



- 1. If a mask becomes damp, please replace it with a new one. Schools have fresh masks if needed.
- 2. Do not re-use a single-use masks.



- 1. Remove a mask from behind (do not touch the front of mask).
- 2. Throw away used disposable masks.
- 3. Wash fabric masks before reusing.
- 4. Clean hands with alcohol-based hand rub or soap and water after removal.

### **District Information**

Most questions can be answered by your school's teachers and administrators so please start there to get a quick answer. ### BILITERACY

**Do you know more than one language?** If so, you might want to consider trying for the **California State Seal of Biliteracy!** This is recognition by the State for graduating high school students who have attained a high level of proficiency in listening, speaking, reading, and writing in one or more languages in addition to English. Students get a gold seal affixed to their diploma or transcript. (FYI, ASL is an eligible language as are languages that do not have a written system).

**COVID-19 Testing is available** for close-contact students and staff who exhibit COVID-19 like symptoms. Staff are required to test and we recommend students be tested. SDUHSD will soon be offering testing twice a week for students and staff. Testing is also currently available through your healthcare provider, or through SDUHSD if you are a close contact student, or an employee. ### FACE COVERINGS (Masks)

<u>Masks</u> are available in all classrooms and the front office of all sites. <u>Face Shields</u> may be worn for those who cannot wear a face covering due to a medical condition or other exemption.

- 1. What constitutes an acceptable mask? Face coverings for school means a surgical mask, a medical procedure mask, a respirator worn voluntarily, or a highly woven fabric or non-woven material of at least 2 layers. A face covering should not have visible holes or openings, and must cover both the nose and mouth.
- 2. Please note that a face covering does not include a scarf, ski mask, balaclava, bandana, turtleneck, collar, or single layer of fabric. (California Code of Regulations 3205, section 8).
- 3. Masks are required indoors at our school sites, and **must cover both the nose and mouth** at all times. Activities that require the removal of masks should be done outdoors.

**VACCINATION CLINICS** SDUHSD hosted 3 vaccination clinics over the summer, and is trying to schedule additional clinics at school sites in the near future. Individuals age 12 and over are eligible for vaccines. **Parental consent** is required for all eligible minors to be vaccinated. In the interim, you may use the link for <u>COVID Vaccine Locations</u>. Vaccinations are required for all school employees. School employees that do not provide verification are required to be tested weekly. (School employees with questions should contact their supervisor or the SDUHSD Human Resources department).

Test date: Saturday, October 16, 2021.

The PSAT/NMSQT® (PSAT/National Merit Scholarship Qualifying Test) is a 2.5-hour version of the College Board's SAT®. The PSAT/NMSQT® measures verbal, mathematical, and writing abilities important to success in university and provides practice for taking the SAT® in their senior year. The PSAT/NMSQT® can be used to predict performance on the SAT, for those students who intend to take the SAT. The PSAT® is not used in US university admission; scores will be sent only to the student and to the school. In the grade 11 year, the PSAT/NMSQT® exam is also the qualifying exam for the National Merit Scholarship.


